Our Guarantees to You

- We will notify you of **ways that your tax burden can be reduced.**
- We will provide **online access** to your current year tax returns and source documents through the client portal; some prior year information may also be available. **If you do not yet have a client portal we charge a onetime set-up fee of \$35.**
- We will provide **free electronic filing** of your tax returns with the appropriate taxing authorities and free email notifications when your e-filed tax returns have been accepted¹. Please be sure to give us your most current email when you supply us with your tax documents.

The Investment

- Your all-inclusive investment with us, assuming no material changes² from the prior year, will be similar to the prior year with us, considering the nominal industry-standard annual inflation.
- **The full fee is due when your returns are completed.**

Your Guarantees to Us

- You will do your best to accumulate your tax information in an orderly manner and submit the information as early as possible.
- You understand that no appointments will be scheduled during Tax Crunch Time (April 1 – April 15).
- You understand that if you submit your tax documents to us after April 15, it may take additional time for your tax return to be ready based on adjusted seasonal hours.

Notes:

1. Some tax authorities require returns to be filed by paper. All returns allowed to be e-filed will be e-filed. Email notification of receipt only applies to returns that are electronically filed.
2. This is only valid for returns received on or before March 31, 2021. If you owe taxes, you may incur penalties and interest charges for payments received after April 15, Nelson Co. will not be responsible for those interest charges and/or penalties.
